ZONING COMMISSION

ORDERED:

That after public notice and hearing as prescribed by law, the following districts established by the Zoning Commission of the District of Columbia, as shown in the Official Zoning Map and Atlases, are hereby modified and amended.

The following six cases establish the zoning of property formerly in a public street or alley now closed by the Commissioners of the District of Columbia, or the District of Columbia Council under authority of the D. C. Code of Laws, which is now un-zoned:

- S.O. 65-453 Change to C-2-A that part of the alley closed in Square 2847 adjacent to lots 845 and 847 and change to R-4 the remainder of the alley closed in Square 2847 (Book 152, page 121 records of the Surveyor, D. C.)
- S.O. 66-403 Change to R-1-B that part of public alley in Square 1371 closed and adjacent to lots 56, 859, 802, 2 and 5 (Book 152, page 9 records of the Surveyor, D. C.)
- S.O. 67-124 Change to C-2-A that part of Myrtle Street, N. E. in Square 675 extending to a depth of 100 feet from Myrtle Street and change to C-M-3 the remainder (Book 153, page 34 records of the Surveyor, D. C.)
- S.O. 67-179 Change to R-4 that part of I Street, N. W. closed between M Street, N. W. and the northerly property line of lot 118 in Square 620 (Book 153, page 17 records of the Surveyor, D. C.)
- S.O. 67-36 Change to R-1-B that part of public alley closed in Square 5202 and adjacent to lots 847, 23, 862 and 854 (Book 153, page 24 records of the Surveyor, D. C.)
- S.O. 66-342 Change to R-5-A the public alley closed in that part of Square 5084 bounded by Blaine St., Ames St., 41st St. and 42nd St., N. E. (Book 153, page 52 records of the Surveyor, D. C.)



- S.O. 65-530 Change to C-4 that part of D Street, N. W., and alley closed in Square 378 adjacent to lots 852 and 820 (Recorded in book 152, page 126 records of the Surveyor, D. C.)
- S.O. 65-448 Change to C-1 that part of 54th St., 53rd St., and Foote St., N. E., and public alleys; closed in Squares 5218, 5219, 5223, 5224 and parts of public alleys in Square 5220 and 5222. (Recorded in book 139, page 1 records of the Surveyor, D. C.)



- S.O. 65-448 Change to C-1 that part of 54th St., 53rd St., and Foote St., N. E., and public alleys; closed in Squares 5218, 5219, 5223, 5224 and parts of public alleys in Square 5220 and 5222. (Recorded in book 139, page 1 records of the Surveyor, D. C.)
