

GOVERNMENT OF THE DISTRICT OF COLUMBIA
BOARD OF ZONING ADJUSTMENT



Application No. 12927, of Colonial Parking, Inc., pursuant to Sub-section 8207.2 of the Zoning Regulations, for a special exception under Paragraph 4101.41 to continue the use of a parking lot in an SP-2 District at the premises 809-813 - 6th Street, N.W. (Square 485, Lots 10, 11 and 12).

FINDINGS OF FACT:

1. The subject lot is located on the east side of 6th Street between H and I Streets, N.W. and is known as 809-813 - 6th Street, N.W. It is in an SP-2 District.
2. There is a fifteen foot public alley to the rear of the property, and a ten foot public alley to the south of the property. Surrounding the parking lot are churches and church related uses, rooming houses, small stores and restaurants. The lot is approximately 1500 feet from the Judiciary Square metro station. To the west and north of the site the zoning is predominantly commercial. To the east and south of the site the zoning is SP-2. Most of the area is occupied by the various court houses.
3. The subject parking lot was last approved for a period of two years by BZA Order No. 12341, dated March 18, 1977.
4. The subject parking lot is leased on a yearly basis to the District of Columbia Department of Corrections. D.C. Government vehicles and the private cars of it's staff are parked on the lot. Because of the nature of the work requiring the use of the vehicles during the day, most parking is on a short term basis. There is no commuter parking.
5. The lot provides twenty self-park spaces.
6. Access to the parking lot is from the alleys. There is no curb-cut on 6th Street. There is a fourteen foot aisle and an eighteen foot turnway from the 6th Street alley.

7. The owner has no immediate plans for the development of the subject lot. He testified that he wishes to acquire more property so that the site would be sufficient to construct an office building. He is also willing to sell the subject lot, which contains approximately 5,140 square feet, for development.

8. The lot is paved with an all-weather impervious surface. Concrete bumper stops are provided at the front of the lot along 6th Street.

9. Advisory Neighborhood Commission - 2C made no recommendation on the application.

10. There was no opposition to the application.

CONCLUSIONS OF LAW:

Based on the record, the Board concludes that the applicant has substantially complied with the requirements of Paragraph 4101.41 of the Zoning Regulations. The Board concludes that the parking lot use is so located and all facilities thereof are so designed that they are not likely to become objectionable to adjoining or nearby property, because of noise, traffic or other objectionable conditions. The Board further concludes that the present character and future development of the neighborhood will not be affected adversely by the use and that the subject lot provides short term parking.

The application can be granted as in harmony with the general purpose and intent of the Zoning Regulations and Map, and will not tend to affect adversely the use of neighboring property.

Accordingly, it is ORDERED that the application is GRANTED SUBJECT to the following CONDITIONS:

- a. Approval shall be for a period of THREE YEARS from the date of the expiration of the previous Certificate of Occupancy, namely March 18, 1979.
- b. All areas devoted to driveways, access lanes, and parking areas shall be maintained with a paving of material forming an all-weather impervious surface.

- c. An eight inch coping shall be erected and maintained along each side of all driveways to protect the public space.
- d. Bumper stops shall be erected and maintained for the protection of all adjoining buildings.
- e. No vehicle or any part thereof shall be permitted to project over any lot or building line or on or over the public space.
- f. All parts of the lot shall be kept free of refuse or debris and shall be paved or landscaped. Landscaping shall be maintained in a healthy growing condition and in a neat and orderly appearance.
- g. No other use shall be conducted from or upon the premises and no structure other than an attendant's shelter shall be erected or used upon the premises unless such use or structure is otherwise permitted in the zoning district in which the parking lot is located.
- h. Any lighting used to illuminate the parking lot or its accessory building shall be so arranged that all direct rays of such lighting are confined to the surface of the parking lot.
