Application No. 14795 of Jerome and Barbara Shapiro, pursuant to 11 DCMR 3107.2, for a variance from the rear yard requirements (Sub-section 404.1) to construct a greenhouse addition to an existing single family dwelling in an R-1-B District at premises 3805 Gramercy Street, N.W. (Square 1851, Lot 72).

SUMMARY ORDER

The Board duly provided timely notice of the public hearing on this application by publication in the D.C. Register, by mail to ANC 3E and by mail to owners of property within 200 feet of the property.

The site of the application is located in Advisory Neighborhood Commission ("ANC") 3E and in proximity to ANC 3G. ANC 3E, which is automatically a party to the application, filed a written statement in support of the application. ANC 3G filed no written statement nor did ANC 3G request to be treated as an affected ANC.

As directed by 11 DCMR 3324.2, the Board has required the applicant to satisfy the burden of proving the elements which are necessary to establish the case for a variance from the strict application of the requirements of 11 DCMR 404.1. No person or entity appeared at the public hearing in opposition to the application or otherwise requested to participate as a party in opposition in this proceeding. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3107.2, and that the requested relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and maps. It is therefore ORDERED that the application is GRANTED.


