Application No. 15006, of the Business and Professional Women's Foundation, pursuant to 11 DCMR 3108.1, for a special exception under Section 508 for a proposed addition to a non-profit office building in an SP-1 and C-2-A District at premises 2012 Massachusetts Avenue, N.W., (Square 95, Lot 3).

SUMMARY ORDER

At the public hearing, the applicant requested that the record reflect the correct name of the owners of the subject property. Instead of the National Foundation of Business and Professional Women's Clubs, Inc., it should be, the Business and Professional Women's Foundation.

The Board duly provided timely notice of the public hearing on this application, by publication in the D.C. Register, and by mail to ANC 2B and to owners of property within 200 feet of the site.

The site of the application is located in Advisory Neighborhood Commission ("ANC") 2B, which is automatically a party to the application, by letter dated May 10, 1989, submitted written issues and concerns in support of the application.

As directed by 11 DCMR 3324.2, the Board has required the applicant to satisfy the burden of proving the elements which are necessary to establish the case for a special exception pursuant to 11 DCMR 508. No person or entity appeared at the hearing or otherwise requested to participate as a party in this proceeding. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3108, and that the requested relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and maps. It is therefore ORDERED that the application is GRANTED.
