Application No. 15238 of 5619 Colorado Avenue Associates, pursuant to 11 DCMR 3108.1, for special exceptions under Sections 357 and 358.7 to allow a youth rehabilitation home for ten youths and nine staff on the first and second floors and to locate a facility within 500 feet of an existing community based residential facility with five or more residents in an E-5-A District at premises 5619 Colorado Avenue, N.W., (Square 2798, Lot 24).

SUMMARY ORDER

The site of the application is located in Advisory Neighborhood Commission ("ANC") 4C. ANC 4C, which is automatically a party to the application, did not file a written statement of issues and concerns.

The Board duly provided timely notice of the public hearing on this application, by publication in the D.C. Register, and by mail to ANC 4C and to owners of property within 200 feet of the site.

As directed by 11 DCMR 3324.2, the Board has required the applicant to satisfy the burden of proving the elements which are necessary to establish the case for a special exception pursuant to 11 DCMR 357 and 358.7. No person or entity appeared at the hearing or otherwise requested to participate as a party in this proceeding. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3108, and that the requested relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and maps. It is therefore ORDERED that the application is GRANTED.


