Application No. 15400 of the Star of Bethlehem C.O.G. I.C., pursuant to 11 DCMR 3108.1 for special exception under sections 206 and 207 to establish a child development center and private school of 75 children in an R-1-B District at premises 5331 Colorado Avenue, N.W., (Square 2716, Lot 84).

ORDER TO DISMISS

The subject application was accepted for filing on July 19, 1990. The materials submitted by the applicant were not sufficient to permit further processing of the application in accordance with the provisions of Chapter 33 of the Zoning Regulations. The staff of the Zoning Secretariat verbally informed the applicant of the further submissions necessary to complete the filing requirements.

By letter dated October 1, 1990, the Executive Director of the Office of Zoning Secretariat informed the applicant that the application could not be processed further unless the applicant submitted the specified materials necessary to complete the application. The Executive Director further advised the applicant that failure to submit the specified materials by October 24, 1990 would result in a recommendation from the staff to the Board that the application be dismissed.

At the Board's public meeting of November 7, 1990, the staff noted that the applicant had not submitted the materials requested and recommended that the Board dismiss the application for failure of prosecution.


Upon consideration of the foregoing facts, it is hereby ORDERED that the application is DISMISSED for failure of prosecution.
