Application No. 15727 of the Christian Love Baptist Church, pursuant to 11 DCMR 3107.2, for a variance from the width of an aisle for required parking (Subsection 2117.5), and a variance from the maneuvering and accessibility space requirement (Subsection 2115.13) for an addition to a church in a C-3-A District at premises 818 Bladensburg Road, N.E. (Square 4072, Lot 99).

HEARING DATE: October 14, 1992  
DECISION DATE: November 4, 1992

SUMMARY ORDER

The Board provided proper and timely notice of public hearing on this application by publication in the D.C. Register, and by mail to Advisory Neighborhood Commission (ANC) 5B and to owners of property within 200 feet of the site.

The site of the application is located within the jurisdiction of ANC 5B. ANC 5B, which is automatically a party to the application, filed a written statement of issues and concerns in support of the application.

As directed by 11 DCMR 3324.2, the Board has required the applicant to satisfy the burden of proving the elements which are necessary to establish the case for a variance from the strict application of the requirements of 11 DCMR 2117.5 and 2115.13. No person or entity appeared at the public hearing in opposition to the application or otherwise requested to participate as a party in this proceeding. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3107, and that the requested relief can be granted without substantial detriment to the public good and without substantially impairing the intent, purpose, and integrity of the zone plan as embodied in the Zoning Regulations and Map. It is therefore **ORDERED** that the application is **GRANTED**, **SUBJECT** to the **CONDITION** that the parking layout and landscaping shall be as shown on the revised plans marked as Exhibit No. 27 of the record.


