ORDER DISMISSING APPLICATION

Application No. 15827 of H.R. Crawford, pursuant to 11 DCMR 3108.1, for a special exception to use the premises as a "Youth Rehabilitation Home"-ages 13-19, 10 clients, 12 staff at 301 Parkland Place, S.E., (Square 5988, Lot 60).

DECISION DATE: September 3, 1997

Application No. 15827 of H.R. Crawford was filed with the Board of Zoning Adjustment on March 31, 1993. The application was incomplete in that no letter of authorization was included and the requisite additional fees had yet to be remitted. As no action was taken to complete the application, or to remit the requisite fees, a letter was sent to the applicant on June 12, 1997 by Madeliene H. Dobbins, Director of the Office of Zoning, asking the applicant to indicate whether he intended to proceed with or withdraw the application. Despite the request for a response, no further action was taken by the applicant to either withdraw the application or to proceed with the case.

The only reasonable result of the applicant's election not to proceed pursuant to the Board's Rules is dismissal of the application.


The applicant has left the Board no reasonable alternative other than to dismiss this application for failure to prosecute.

Accordingly, it is ORDERED that this application is DISMISSED for want of prosecution.
