Application No. 15914 of Christian Kelleher, pursuant to 11 DCMR 3107.2, for a variance from the use provisions (Subsection 330) to allow a woodworking/crafts studio on the first floor in an R-4 District at the rear of 775 Fairmont Street, N.W. (Square 2885, Lot 862).

HEARING DATES: March 9 and June 8, 1994  
DECISION DATE: June 8, 1994 (Bench Decision)

ORDER

This application appeared on the preliminary agenda of the public hearing of June 8, 1994 because the applicant failed to comply with Section 3317 of the Board's Rules. The applicant did not submit a sworn affidavit demonstrating that the property had been posted with notice of the public hearing as required by the Board's Rules.

At the public hearing of June 8, 1994, the application was called as a preliminary matter. There was no response from the applicant or any other person representing the applicant. The staff informed the Board that attempts were made to contact the applicant by telephone on three occasions during the three-day period prior to the hearing. Staff left a message for the applicant indicating that his presence at the hearing would be necessary. Alternatively, staff requested that the applicant submit a letter notifying the Board of his intentions with regard to the application. No letter formally requesting withdrawal or postponement of the application was received prior to the public hearing. Neither the applicant nor a representative returned staff's telephone calls or appeared at any time during the hearing.


Upon consideration of the above facts, it is hereby **ORDERED** that the application is **DISMISSED** without prejudice for want of prosecution.
