Application No. 15989 of Washington Park Associates, pursuant to 11 DCMR 3108.1 (**new section 3104.1**), for a special exception under Section 214 to establish accessory commercial parking spaces in the basement of a condominium apartment building in a C-3-B District at premises 1099 22nd Street, N.W. (Square 73, Lot 81).

DISMISSAL ORDER

This application was originally scheduled for public hearing on October 12, 1994, but was cancelled because of incorrect information in the description of the application. 
