
Dear Pastor Pratt:



If you require additional assistance, please contact me on (301) 218-8418 or (202) 246-2610. Thank you for your assistance and cooperation in this matter.



Dear Elder Pratt:

This office is in receipt of an application that was filed by you on June 22, 1999, at 5582 Jay Street, N.E., for the construction of a church, (Square 5214, Lot 54). On several occasions and as late as January, 2000, Ms. Pelzer spoke with you and informed you that the application was not complete and could not proceed unless you first obtain a ZA's memorandum citing the required relief or you obtained a lawyer's or architect's certification. In the last conversation with this office, it was the understanding that you would obtain a Zoning Administrator's (ZA's) memorandum.

Since it has been over eleven months and the application has remained dormant, the Office of Zoning must resolve the status of the referenced application.

If the Office of Zoning has not heard from you in writing by June 15, 2000 affirming your intentions to proceed in the near future, the staff will recommend to the Board that this case be **DISMISSED** at its July public meeting.
