Application No. 16599 of Tia Cudahy, pursuant to 11 DCMR 3104.1, for a special exception under Section 223 for additions to the side and rear of an existing single-family dwelling in an R-3 District at premises 1521 31st Street, N.W. (Square 1269, Lot 370).¹

SUMMARY ORDER

The zoning relief requested in this case is self-certified, pursuant to 11 DCMR 3113.2.

The Board provided proper and timely notice of the public hearing on this application by publication in the D.C. Register, by mail to Advisory Neighborhood Commission (ANC) 2E, and to owners of property within 200 feet of the site.

The site of the application is located within the jurisdiction of ANC 2E. ANC 2E, which is automatically a party to this application, submitted a written statement supporting the applicant's proposal to construct the proposed addition. The ANC, however, did not take a position on the Applicant's use of a portion of the structure to house an accessory apartment.

As directed by 11 DCMR 3119.2, the Board required the applicant to satisfy the burden of proving the elements, which are necessary to establish the case for a special exception pursuant to 11 DCMR Section 223. No person or entity appearing as a party to this case testified in opposition to the application. Accordingly, a decision by the Board to grant this application would not be adverse to any party.

Based upon the record before the Board, the Board concludes that the applicant has met the burden of proof, pursuant to 11 DCMR 3104.1, that the requested relief can be granted as being in harmony with the general purpose and intent of the Zoning Regulations and Map. The Board further concludes that granting the requested relief will not tend to affect adversely the use of neighboring property in accordance with the Zoning Regulations and Map. It is therefore **ORDERED** that the application be **GRANTED ONLY FOR THE CONSTRUCTION OF AN ADDITION TO THE DWELLING UNIT.**

¹ The Board amended the application to indicate that the applicant is seeking zoning relief to establish an accessory apartment use at the site. The Board did not take a position on the accessory apartment use and deferred making a decision until September 2000.

Pursuant to 11 DCMR 3101.6, the Board has determined to waive the requirement of 11 DCMR 3125.3 that findings of fact and conclusions of law accompany the order of the Board. The waiver will not prejudice the rights of any party, and is appropriate in this case.
