
Dear Members of the Board:

On behalf of the appellant in the above-referenced case, pursuant to 11 DCMR §3113.10, this letter is to withdraw and have dismissed with prejudice the above-referenced appeal as moot. The District of Columbia Department of Consumer and Regulatory Affairs (DCRA) has issued a new certificate of occupancy for the Flea Market operation, a copy of which is enclosed.

The District of Columbia requested a postponement of the public hearing previously scheduled for June 5, 2001. The Board granted the postponement of that public hearing to October 16, 2001. In the interim, the appellant has had discussions with the DCRA and the Office of Corporation Counsel concerning the status of the use and resolution of the prior decision of the Zoning Review Branch which had occasioned the appeal. The result of those discussions was the issuance of the enclosed certificate of occupancy. Accordingly, the appeal is moot and is hereby withdrawn and should be dismissed with prejudice.
