Appeal No. 16752 of Advisory Neighborhood Commission 4A, pursuant to 11 DCMR §§ 3100 and 3101 from the decision of Michael Johnson, Zoning Administrator, for the issuance of a certificate of occupancy (#190720, dated May 7, 2001) for an adult development day program for mentally retarded persons, allegedly not meeting the parking requirements (section 2100) in a C-2-A District at premises 5511 14th Street, N.W. (Square 2800, Lot 9).

FINAL ORDER DISMISSING APPEAL

This case involves the appeal of Certificate of Occupancy No. 190720, issued on May 7, 2001, to the Metro Day Treatment Center, Inc., for the purpose of a “day program for mentally retarded persons, adult development.” At the November 6, 2001, public hearing on this appeal, the Office of the Zoning Administrator advised the Board of Zoning Adjustment that a new certificate of occupancy, No. 18366, had been issued to Metro Day Treatment Center on August 31, 2001, to replace Certificate No. 190720. The issuance of the new certificate of occupancy voided Certificate No. 190720. Therefore, the instant appeal is moot. Pursuant to 11 DCMR § 3105.5, “Informal requests for advice or moot questions shall not be considered by the Board.”

Accordingly, the Board hereby **ORDERS BZA Appeal No. 16752 DISMISSED as moot.**


