

Dear Members of the Board of Zoning Adjustment:

It is with great reluctance that ANC 1A withdraws its appeal in the captioned case, as DCRA has not provided a set of fully stamped drawings on which its new permit for the project (Building Permit No. 114636) was based.

Although DCRA provided a set of drawings that appear to resolve each matter raised by the ANC in Appeal No. 17671, only the cover sheet is stamped. We reiterate our position that normal practice and policy is for each relevant sheet to be stamped to ensure that it has been reviewed and approved by the respective discipline, as is the case with life/safety on the drawings provided to the ANC. Such a procedure is the only way to ensure that any future construction will conform to the revised set and the only way to deter potential fraud.

In withdrawing this appeal, ANCLIA notes that its appeal appears to have resulted in a correction of the six areas in which the Zoning Administrator erred in approving Building Permit No. 90426. However, we also note that it took the ZA more than six months after the filing of the appeal to correct the error, while never acknowledging the error to the BZA – in fact, doing just the opposite by defending the appeal. ANCLIA is also troubled by the fact that council for DCRA worked diligently to prevent this case from being heard at all, thereby, attempting to deny the right of appeal to the taxpaying residents living near this project.
